DOMPIERRE DE FONTAINE, Mme, née Marie-Élisabeth Mignot, marquise de Florian

Paris 1715 – château d'Hornoy 22.II.1771
Voltaire's niece, and younger sister of Mme Denis. She married first (1738) Nicolas-Joseph de Dompierre de Fontaine, who died in 1756, then (1762) Philippe-Antoine de Claris, marquis de Florian, uncle of the writer. Voltaire refers to her as "une Rosalba" (letter of 20.I.1754; his letter to her sister of 4.XII.1753 uses the same metaphor; both refer to her chronic ill-health. In a letter to her of 2.VII.1755 Voltaire wrote:

Je vous écris, ma très chère nièce, en fesant clourer au chevet de mon lit votre portrait et celui de votre fils. En vérité, voilà trois chefs-d'œuvre de votre façon qui me sont bien chers, vous, le petit d'Hornoy, et son pastel. Vous ne pouviez faire ni un plus joli enfant ni un plus joli portrait. Le vôtre est parfaitement ressemblant. Vous êtes un excellent peintre...

Her self-portrait (quite possibly but not necessarily in pastel) is lost; it may perhaps relate to an unsigned oil portrait of her attributed to Drouais (formerly at the château d'Hornoy, it was exhibited in 1906 by Duveen and in Paris 1909b when it belonged to Sigismund Reitlinger; it is known from two versions, c.32x24, which fit the Duveen description precisely): the painting, not reproduced, shows her seated holding a drawing crayon in her right hand, a portfolio in the left. The pastel of her son (to whom the abbé Pommery was appointed guardian on his father's death in 1756) has been assumed to be the "petit Savoyard" now at Ferney, but that is evidently one of a number of pastel copies of a painting in the Louvre by F.-H. Drouais (*q.v.*). Some months later Voltaire wrote again (16.XII.1755): "Vous êtes déjà admirée à Genève, et vous l'emportez sur Liotard", and he subsequently corresponded with her concerning his own portraits by Liotard and de Wyl (*q.v.*). Her fragile health is alluded to (8.I.1756): "Aimez-vous toujours à peindre de beaux corps tout nus, en attendant que le docteur Tronchin rétablisse et engrasse le vôtre", but it seems that his niece preferred to copy engravings rather than attend to the ageing philosophe's lubricious fantasies.

It also seems that Dr Théodore Tronchin owned two of her pastels: on 9.X.1764 Karl Graf Zinzendorf visited Tronchin, apparently with Liotard (with whom he had spent the previous day with Voltaire), to see "quelques tableaux de Liotard". After two pastels by him, Zinzendorf mentions "Deux dormeuses de Melle Fontaine, nièce de M. de Voltaire, qui ont l'air de morts qui ont mis du rouge, tant la chair est verte...". They are presumably by rather than of Voltaire's niece (although by that stage she was properly Mme Claris de Florian), and quite probably copies of Boucher's pendant *Dormeuse* and *Voluptueuse*.

A pastel possibly of her sister, now in Geneva, is copied from an oil which was attributed to Carle Van Loo when it too belonged to Duveen (exhibited 1906, no. 8) but

subsequently reattributed to Drouais; it probably belonged to the pastellist.
