# GARDNER, Daniel

Kendal c.1750 - London 8.VII.1805 Gardner (Gardener, Garner) is said to have been born in Kendal in 1750, the nephew of Christopher Redman, upholder and mayor of Kendal (in 1749-50 and 1760-62). The family background is obscure, despite the extensive local searches made by Williamson before 1913, which have not been explored further in the Oxford DNB article (as accessed .IV.2016) or other sources. Research in 2016 indicates that the artist's grandfather was a Daniel Gardner, cordwainer, of Osmotherley, near Ulverston, where he died in 1740. The pastellist's father was Caleb Gardner (also a cordwainer; he became a freeman of Lancaster 1738-9, but was later a grocer in Kendal). On 6.XI.1743 in Millom, he married Elizabeth "Redmon", Christopher Redman's sister. Daniel Gardner, "of Kendal, upholsterer" (his uncle's profession, to whom he may well have been apprenticed), "son of Caleb", also became a freeman of Lancaster in 1768-69. His baptismal record has not been located (there is evidence that his family were Baptists, and minutes of Baptist births in Kendal are lost), but he may have been born before the 1750 date that Williamson cited without authority. A Lancaster bye-law enacted in 1758 required apprentices to serve a full term of seven years before obtaining freedom: the traditional 1750 year of birth would imply that Daniel was apprenticed aged 12 or younger.

Gardner was said (Romney 1830, p. 12) to have been taught by George Romney, but claimed to have learned little from him (Romney in fact left for London in 1762). Gardner himself moved to London (Cockspur Street) at some stage in the late 1760s. (A Watson print of 1768 listed by Williamson and cited by Grundy 1921 as evidence of an earlier arrival appears to be a confusion.) He is recorded as having entered the Royal Academy Schools on 17.III.1770 (no age is given), where he was taught by Zoffany, Dance, B. West, Cipriani and Bartolozzi (qq.v.). He was one of four students awarded a silver medal for drawing academy figures at the Royal Academy Schools on 10.XII.1771. His grandson's letter of 16.IX.1856 names the submission as a cravon painting of The Chained Captive, and it has been suggested that this was one of his pastels of George White (v. Williamson 1921; Postle 1995; Forrester 2005); White was also the subject of portraits by many other artists including Reynolds and Russell (1772). He exhibited a portrait of an old man (possibly the same picture) at the Academy of that year, but no further works were shown at the major London exhibitions. Perhaps this was because of the personality described by James Northcote in a letter to his brother of 29.111.1772 (RA archives, NOR/8):

Last Sunday I breakfasted with Mr Gardner at half past eight and remained with him till past three in the afternoon, for he would not let me go. He is a person of very great sense and to me behaves with much good nature, tho' he has, at the Academy, the

character of very great pride and ill-nature, and not quite without foundation as he is very blunt and all those who he does not like he will not take any notice of and hardly speaks to them; and following too much his own inclination, does not enough conform to the customs of the polite world. ... But to me he is quite otherwise, for he so much liked me that he told me the opinion he had of himself – that he thought himself proud and not good-natured, that he had some envy and much ambition, for in the arts those who love painting and, from experience, know the vast difficulty of excelling, look up at those men who have produced such wonders, with all the admiration zealots in religion can pay their saints.

His "peculiar disposition" was noted too by Farington (*Diary*, 17.XII.1806), who said he was "extremely parsimonious" and delighted in arguing.

Northcote (letter of 21.XII.1771, RA archives, NOR/7, incorrectly transcribed in Whitley 1928) tells us that Gardner had met Reynolds through Mr Elliott of Port Eliot (Edward Elliot (1727 1804), created 1st Baron Eliot 1784). He is widely said to have worked briefly in Reynolds's studio c.1773 (Mannings 2000, p. 514 puts the date back to the late 1770s), for which the evidence is unsatisfactory. Williamson's statement seems to be an inference from the extravagant theory possibly triggered by a confusion with the work's patron - that Gardner painted the foliage in Reynolds's Montgomery sisters. He was of course influenced by Reynolds's compositions, several of which he copied (for example a full-length portrait of the Duke of Northumberland in his coronation robes draws from Reynolds's portrait of Lord Rockingham, perhaps through the 1774 engraving). But in a letter of 12.XI.1779 Gardner excuses the deficiencies in what "is absolutely the first oil picture I ever finished": an unusual claim had he worked for Reynolds.

Within a few years of his silver medal he had made a considerable impression. The pastellist John Warren (q.v.), writing to his patron Andrew Caldwell from Bath 23.XL1776, refers to reports that Hugh Douglas Hamilton "is gone to Ireland", implying that he had failed in competition with Daniel Gardner, to Warren's puzzlement as Hamilton "gives such a truth both of form & colour as makes his works far superior" while Gardner was "a man of so little comparative Merit", who, though "not without taste & Genius", was "a bad Draughtsman & clumsy in his execution".

Gardner married Ann, the sister of the engraver Francis Haward, on 8.X.1774 (St George's Hanover Square; not 1776 as Williamson and other sources have); one of the witnesses was the engraver Thomas Watson who had already engraved several plates after Gardner's work. There were two sons; Ann died shortly after giving the birth to the second in 1781. The elder, and only surviving, son George was sent to Kendal and brought up by the Pennington family with whom Gardner had formed a close relationship. He was otherwise notoriously anti-social, although he is said to have enjoyed playing with children. By 1781, he was already celebrated in verse, with William Hayley praising his "Taste and Ease".

Gardner seems to have been pretty successful as a portraitist, building a clientèle among families such as the Heathcotes, of whom he painted at least 25 portraits, or the interrelated Elliot, Horneck and Scawen families. A single page from his account book, from 1792, has survived; it suggests that his prices ranged from 5 gns to 23, although neither medium nor format is indicated. The engraving of numbers of his portraits was probably more lucrative than the execution of the orginals. In a letter to his brother Lord Grantham, Frederick Robinson (23.II.1779, Bedfordshire and Luton Archives, L30/14/333/181) reported, among a list of artists active in London, that "Mr Gardner in Bond St. draws in crayons in the manner of Hamilton (but in general full length figures) etc. Little boy [his nephew, later Earl of Morley] to sit for him." By 1787 he was able to acquire an expensive house in Kendal, and at his death had an income of some £1500 a year: no doubt accumulated through hard work, and conserved through his extreme parsimony.

Gardner lived initially at 120 New Bond Street, moving to 142 in the same street in 1781 (this was the address of Thomas Watson on the 1774 plate of his print after Gardner's Lady Jersey, although by 1776 Watson had moved to no. 112). In 1793 he moved to 3 Beak Street, Golden Square (where Williamson says he lived until his death). A brief trip to Paris took place in 1802-3, when he visited the Louvre (it is unclear if he was the Mr Gardner, painter who accompanied John Opie on a trip to Flanders in 1786). Gardner died from liver failure, on 8.VII.1805, in Warwick Street, Golden Square (according to the Gentleman's magazine; this may be the Beak Street house). The burial entry in St James's Piccadilly records his names as Gardener ( a spelling also seen in some Kendal sources: note that Romney 1830, who prints Gardner in the book, has an erratum correcting this to Gardener, p. 333). There was no will, but his only child, George Gardner of Lincoln's Inn, inherited the estate with a net value of over £7600 (detailed in Williamson 1921). A large collection of his works passed to the artist's granddaughter Anne Eliza, Mrs Dixon. They were then sold to Lord Carlingford and in turn to Lady Strachey, 63 of whose portraits were dispersed at Christie's on 17.VII.1911. This followed soon after the 1908 sale of the portrait of Lady Fawkener for 1250 gns, a price which brought Gardner out of obscurity.

Gardner seems to have valued the somewhat rough, unfinished appearance of much of his work, and from the mid-1770s he practised highly original techniques in which pastel, scraped to dust with a knife, was applied, sometimes using brandy as a vehicle, to achieve a sharp brilliance; transparent layers of pigment were overlaid to mimic the effects of shot silk. Gardner used dry pastel for faces, gouache for dresses and watercolour for backgrounds (often outdoor, rustic scenes), a mixture which has left many conservation problems (Mrs Marton is a good example: v. Cumming & Colbourne 1998); the technique however echoes that of miniaturists such as J.-A.-M. Lemoine who inserted slips of ivory under areas of flesh in larger miniatures on card. These techniques were in use quite early on, but are not always obvious at first sight of the small ovals he produced at

the start of his career which have understandably been confused with Hamilton's: but the main differences lie in Hamilton's use of sharp black chalk directly on his faces, with regular parallel hatching, while Gardner confines himself to hatching in pale ochres, often in random patterns; the presence of gouache or wetstumped pastel normally points to Gardner. But most of his work involves more elaborate and somewhat artificial compositions, in which figures and draperies are contorted to extremes; while limbs are sometimes elongated, often it is the heads which are too large.

According to Williamson, Gardner bought his colours mostly from Roberson and Miller (a firm only recorded from 1828 in the NPG database of British artists' suppliers), sometimes from Newman in Soho Square. Like other pastellists he usually relied on a mixture of blue pigment and yellow lake to produce his greens, but the lakes faded rapidly. Williamson also suggests that he used Scheele's Green after it was introduced in 1778, but with unsatisfactory results. He worked in a wide range of sizes and formats, popularising the landscape oval shape in particular for conversation pieces. Some of these are among the largest pastels ever made. From about 1779 he also produced conventional oil paintings. His work is often framed in a characteristic fluted giltwood model which he may even have designed himself. Apparently he also had a lockable frame to conceal uncompleted work from clients' inspection during sittings.

Despite his distinctive style, his work is seldom signed, and much of Gardner's œuvre was reattributed to other artists throughout the nineteenth century (the 1894 Russell exhibition included a number of his works), and only during the 20th century was his reputation reestablished. It is not clear whether he can properly be described as a "pastellist" (although some of the earliest works may have been drawn exclusively in that medium), but the mixture of media he developed was taken up by English artists from Downman to Peter Romney and Masquerier (although not by Constable, whom Gardner befriended), and continued seamlessly into the nineteenth century, in contrast to the fairly precise end to the purer tradition practised in France. Noting his faulty draughtsmanship, Grundy nevertheless considered him the most successful English pastellist of the eighteenth century, surpassing Reynolds in freedom and spontaneity, and Downman in attaining finer and richer colour. That is not an obvious conclusion today, and some will side with Kaines Smith in his review of Williamson 1921: "the reader is left with an uneasy feeling that the contemporary critics were right, and that the greatest service that the author has rendered to art is in relieving Reynolds of responsibility for works by so inferior a hand as that of Gardner." But that is to miss the point of Gardner: at his best, as in conversation pieces such as the Sturt and East families, his vivid colouring and inventive compositions convey a joie de vivre rarely found in the portraiture of the day.
