

**GOBERT, Pierre**

Fontainebleau 1662 – Paris 1744

The son of a sculpteur du roi, the portrait painter Gobert was *agr  * by the Acad  mie royale in 1686. He may have worked in Munich before he was *re  u* in 1701; according to Nagler, as well as portraits of other members of the court, Gobert painted the Kurf  rst in pastel; this may be a confusion with Vivien. He sent numerous portraits to the Salon of 1704 but did not exhibit again until 1737. No pastels have survived, and the few references are probably to copies of his paintings or other confusions such as that over the alleged portrait of Mme de Prie, a pastiche after Rosalba Carriera of Mme de Sabran.
