

# Neil Jeffares, *Dictionary of pastelists before 1800*

### LISIEWSKI, Christoph Friedrich Reinhold

Berlin 1725 – Ludwigslust 1794

Brother of Barbara Rosina and Anna Dorothea, Mme Therbusch (*qq.v.*); pupil of their father Jerzy Liszewski, Liscewsky, Lisiewski or Lisiewsky; court painter to Anna Wilhelmine von Anhalt-Dessau from 1752 to 1772. During his visit to Dessau in 1764, Boswell was shown “some excellent Portraits” by Liszewski belonging to Friedrich Wilhelm von Guericke, Oberhofmeister at the court; the artist “does remarkably well both large Portraits & miniatures”. He was also well known for his candle-light paintings, one of which was exhibited at the Society of Artists in London in 1780.

Lisiewski’s pastels have strong, clean colours and a precision of draughtsmanship and modelling that cause the figures to stand out from the sheet. They are however relatively rare in his oeuvre, only half a dozen examples, from between 1754 and c.1770, being known today. Börsch-Supan describes him as the best pastellist of the rococo era in Berlin, praising his “unerbittlichen Gewissenhaftigkeit der Charakterisierung” and a strength to rival La Tour or Liotard. Only the pastel of Leopold III. can really claim this rank; some of the others retain a provincial woodenness.
