

# Neil Jeffares, *Dictionary of pastellists before 1800*

### TAUBERT, Gustav Friedrich Amalius

Berlin 1755–1839

Taubert studied in Berlin and then Dresden (1782), where he made a number of copies of works in the gallery. Taught by his father, Johann Friedrich (*q.v.*), from whom he learned the art of miniature, Chodowiecki (*q.v.*), and Jacob Seydelmann, he was also for a year a pupil of the pastellist Paul Joseph Bardou (*q.v.*). In 1783 he was in Karlsbad, Prague and Vienna. In 1785, with the support of Graf von Brühl, governor of Warsaw, he moved to that city where he remained until 1794 as court painter to Stanislaw August. He was described as “Pastell Mahler aus Berlin in Warschau” in his submission to the Berlin Akademie of 1788. Following the collapse of Stanislaw’s control, Taubert resumed his travels, and is recorded in Gdańsk and Riga before reaching St Petersburg. He then travelled to Vienna before returning to settle in Berlin. He was a member of the Berlin Akademie by 1798, continuing to exhibit until 1836, and he was a founder member of the Berlin Künstler-Veriens. In the *Maurerisches Taschenbuch* (Berlin, 1802, p. 299), he was recorded as belonging to the masonic St. Johannsloge *Zum goldenen Pflug* in Berlin. He painted genre and history pieces as well as portraits, and worked in miniature, silverpoint, watercolour and oil as well as pastel. The small format full length figures were something of a speciality of his. His 1834 autobiography is transcribed in Lacher 2005.
