VALLAYER-COSTER, Anne

Paris 1744–1818

Daughter of a goldsmith, Joseph Vallayer, established at the Gobelins factory and his wife, née Anne Cornut de La Fontaine, Anne Vallayer, or Valayer, must have come into contact with Madeleine Basseporte (*q.v.*), godmother to one of her sisters. At the inventory of their father (AN Y5276, 18.IX.1770), the girls were represented by Madeleine's husband, Gaspard-Gaëtan Motet (–1776), maître en fait d'armes de l'Académie du roi (his trade card was engraved by Noël Le Mire: Waddesdon). The other two sisters, Henriette-Elisabeth and Simone-Adélaïde, both married members of the Bouhébert family of bankers, Josué and Mathieu respectively; a cousin later married the miniaturist Jean-Baptiste-Jacques Augustin (*q.v.*).

A pupil of Claude-Joseph Vernet (who was also subrogé tuteur of the minors at the 1770 inventory), Anne was *agrée* and *reçue* 1770 as a flower painter, exhibiting from 1775. She also made a small number of portraits, but only one in pastel is known with certainty – the portrait of the queen (who had taken her up the previous year), referred to in a letter of 17.VII.1780 from the artist to d'Angiviller: “Je n'ai pas encore remis la lettre que vous avez eu la bonté de me donner pour la princesse de Chimay parce qu'elle n'était pas à Versailles lorsque j'ai été pour travailler au portrait de la Reine et que l'on m'a conseillé d'attendre que son portrait soit entièrement terminé pour réclamer ses bontés; j'espère que dans les premiers jours de la semaine prochaine je pourrai en faire usage.” In 1781 she was granted lodgings in the Louvre, and that year (23.IV.1781, at Saint-Louis-du-Louvre) she married the lawyer Jean-Pierre-Silvestre Coster (1745–), avocat, receveur general du tabac à Domfront, son of a marchand juge consul.

Although her exhibits in the salon of 1779 seem to have been oils, one critic, the abbé Grosier, called her “la Rosalba de ce siècle.”

The attribution of a still-life in Bordeaux has been questioned, on the basis that she made very few pastels; an alternative attribution to Roland de La Porte is scarcely more plausible as he is not known to have worked in the medium at all. The status of a second cannot be determined in the absence of a photograph. Two profiles in coloured chalk of members of her family traditionally attributed to Vallayer-Coster were rejected in 2006 as they do not show the same characteristics as her signed pastels; with the appearance of a third formerly bearing an attribution to her, the group has been tentatively reinstated.
