LA CROIX, Pierre-Frédéric de

Emmerich 1711 – The Hague 12.XII.1782

The prolific deaf and dumb pastellist Pieter Frederik, or Pierre-Frédéric, de La Croix worked in Amsterdam and The Hague. He is said to have been born in France but research (first published here, in 2024) based on Amsterdam church records reveals his family background, of which an account appears in the *Mémoires* of François Bruys, who died in 1738, and visited Emmerich in 1733, the town in North-West Germany, near the border with the Netherlands, where he met the pastellist's father:

ARTUS DE LA CROIX, Normand d'origine, est Ministre de la Colonie Française d'Emmerick. C'est un honnête homme, qui se fait un vrai plaisir de rendre service dans toutes les occasions qu'on peut lui en procurer. Il a deux fils, dont l'aîné, sourd & muet de naissance, est Peintre à Amsterdam, & le second se destine au Ministère, avec des talens & des moeurs qui font espérer qu'il sera un Prédicateur habile & zélé.

The pastellist's father was this Antonius Arthusius de La Croix, who married Elisabeth Guimon in the Evangelical church in Dusseldorf, 22.VI.1699; a daughter, Susanna Magdalena was baptised there, 29.VIII.1700. In 1704 he became minister at the French church in Minden, and was charged with the "Inspection Cleve", supervising the French reformed churches at Minden, Wesel and Cleve as well as Emmerich where he died in 1755 aged 90.

On 23.IV.1745 in Buiksloot the pastellist married Marie, or Maria, Regnier, with banns read in Amsterdam on 2.IV.1745: this official notice (Gemeente Amsterdam Stadsarchief), which he signed as "Pierre de la Croix", gives his father's name, his age (33) and his origin, "Emberick", an old spelling of Emmerich, the town where he is likely to have been born. Three children followed between 1752 and 1756: Isaac and Susanna (*qq.ii.*) both became painters (Isaac's twin brother Pierre-Louis presumably did not survive). Isaac was baptised by "Jean-André-Rudolf de la Croix, pasteur à Emmerich", evidently Pierre's younger brother mentioned by Bruys. Jean-André-Rudolf was himself married in Amsterdam, 9.IX.1752, to Jeanne-Colombe Goutelle; the banns indicate that he was from Minden, one of his father's other responsibilities.

Shortly before Pieter's death, his sister-in-law, Susanne Regnier, made a will in Amsterdam on 21.V.1782, mentioning that "alle de Famille Schilderyen of Pourtraitten." The pastellist's widow Maria Regnier was buried in the French church in Rotterdam, 18.VIII.1794 (a notice in the *Rotterdamse Courant*, 21.VIII.1794, gave her age as 79).

From 1753 Pierre-Frédéric was a member of Pictura in The Hague (no. 232). He seems to have been self-taught. In addition to the many pastels (the earliest dated of which is from 1753), some early oil paintings also exist (e.g. the 1746 portrait in Zwolle recently identified as of Scheltina Anna Ida Aysma van Laut). His work was engraved by Greenwood, Houbraken, Vinkeles etc. Some of his œuvre may be confused with that of his children.

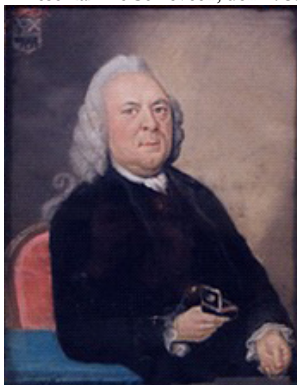

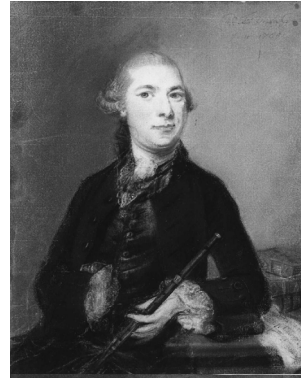

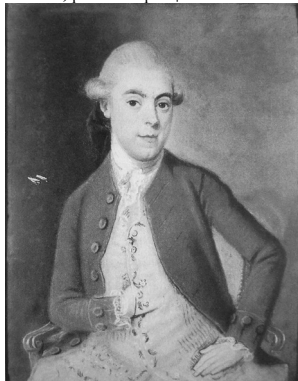
